<u>APPLICATION GUIDELINES</u> FOR NATIONAL CENTRE FOR WRITING – SINGAPORE RESIDENCY PROGRAMME 2025 SUPPORTED BY NATIONAL ARTS COUNCIL

The National Arts Council (NAC) would like to invite you to submit a proposal for the National Centre for Writing (NCW) – Singapore Residency Programme 2025, supported by the NAC. The programme will <u>fully fund</u> the <u>literary</u> <u>writers/translators</u> for their participation.

Submission of applications will close on <u>4 March 2025 (Tuesday), 2359 hrs</u>. Successful applicants will be notified by end-March 2025.

1. OBJECTIVES OF THE PROGRAMME

This initiative is part of the National Arts Council's ongoing efforts to:

- Support Singapore artists in the development of their creative practice through participation in established international platforms.
- Enable networking opportunities and cultural exchanges with international counterparts.

Participants will get the opportunity to tap on a NCW mentor for feedback on their own manuscript and will also receive an honorarium to work on their proposed project and participate in the programme's activities. These activities include recording a podcast for NCW's podcast series, contributing their writing/translation tips for NCW's blog, etc.

Please refer to <u>Annex A</u> for the detailed scope and requirements of the programme.

2. ELIGIBILITY

Applicants eligible for this programme must:

- a. Be Singapore Citizens or Singapore Permanent Residents who are published writers/translators in any of Singapore's four official languages: English, Chinese, Malay or Tamil.
- b. Be actively engaged in the literary arts industry.
- c. Be able to converse and write in English.
- d. Possess a strong track record, strong artistic merit, and commitment towards advancing the art form and contributing to the Singapore arts scene.

3. ASSESSMENT

Applicants will be assessed based on a competitive evaluation process according to the following criteria:

- a. Artistic merit and potential of the applicant, based on the information provided in the application form and CV.
- b. Benefit and relevance of the programme to the applicant's creative and professional development.
- c. Benefit and relevance of the applicant's proposal to the history or culture of the city of Norwich and/or the National Centre for Writing's key areas of focus, which include:
 - (i) connecting people to Norwich's medieval trade and migrant heritage;
 - (ii) promoting diversity, inclusion and anti-racism, especially among Black, Asian and Ethnically Diverse literary communities;
 - (iii) using creative writing, thinking and imagination to enrich learning among Primary and Secondary students; and
 - (iv) understanding how words and ideas can help connect people, raise awareness, and promote physical and mental wellness to create a society that reflects and values a diverse range of stories.
- d. Ability and commitment to undertake and complete the programme for its whole duration (i.e. one month for the in-person programme and six months for the virtual programme).
- e. Capacity and commitment to the development and contribution to the Singapore arts scene.

It is preferred that the applicants should:

- a. Be inclined to learn, explore different perspectives, and share their own knowledge and perspectives on creative writing.
- b. Have works translated into English, if the applicant's works are written in another language (i.e. Chinese, Malay or Tamil).
- c. [for the translators' programme] Propose a literary work authored by a Singaporean writer for translation during the programme.

About the National Centre for Writing (UK)

The National Centre for Writing (NCW), previously known as Writers' Centre Norwich, has had a long history in working with writers and writing. As a major literary arts portfolio organisation in the UK, it is funded by the Arts Council England and has strong links with the British Centre for Literary Translation (BCLT). Based in Norwich, one of the UNESCO Cities of Literature, NCW aims to be a physical and virtual space for writers, literary translators and those working in the world of literature to meet, learn and collaborate. In addition to their literary programming for the reading public, NCW organises workshops, mentoring and other opportunities for writers and translators at different stages in their career, and participates in projects that range from international partnerships to literary festivals.

Other Details and Requirements

- 1. [For the in-person residency] The selected participants will receive a stipend to cover meals and have their airfare, lodging, transport, insurance and hospitality costs (to participate in the activities required by the programme) covered while they attend the residency.
- 2. [For the virtual residency] The selected participants will receive a stipend to work on their proposed project/s and participate in the activities required by the programme.
- 3. An applicant, upon being notified that their application is successful, shall inform NAC of their acceptance within 14 days of the day of the notification. Failure to meet this deadline will be deemed as a withdrawal of the application.
- 4. The successful applicant is expected to be involved in NAC publicity (all media forms) related to the programme at any time before, during, or upon completion of the programme.
- 5. The successful applicant should be able to devote dedicated time on a regular basis to the programme and is expected to contribute to the activities of the programme and actively apply themselves to developing their writing/translation skills over the course of this residency.
- 6. To help NAC and NCW in the evaluation and management of the programme, the successful applicant should provide NCW with feedback summarising their key learning points, the highlights of their virtual residency experience, and any short and/or long-term initiatives arising from ideas and/or skills gained from the mentorship, upon completion of the programme.
- 7. NAC also reserves the right to review or withdraw the programme award should any of the following occur:
 - a. The proposed project receiving the funding is changed significantly without the prior written approval of NAC. NAC must be informed in writing of any changes to the proposed project at least seven (7) working days prior to the project's original execution date.
 - b. Wrong and/or misleading information is provided in the application form, either deliberately or otherwise.
 - c. Participation in any Illegal or negligent acts during any point of the programme, which will adversely affect the reputation of NAC, NCW, any government bodies, public institutions, or national leaders.
